

Wellness Advocate Shared Events Calendar – Terms and Conditions

This Shared Events Calendar is a community resource available to dōTERRA Wellness Advocates to promote in-person and online events for the purpose of education, connection, and community growth. By posting or participating in events listed on this Calendar, you agree to the following terms and conditions:

1. Eligibility

Only current dōTERRA Wellness Advocates may post events to the Calendar.

Events must be open to the public, and aligned with dōTERRA's standards and mission.

2. Open Attendance

Events posted on the Calendar must be open to all—including non-dōTERRA individuals and dōTERRA members regardless of team, rank, or organizational affiliation.

Exclusive or team-only events may not be posted.

3. Prohibition on Cross-Recruiting

In accordance with the AU and NZ Policy Manuals, cross-company recruiting is strictly prohibited. Specifically:

“Cross-company recruiting consists of the actual or attempted solicitation, enrolment, encouragement, or effort to influence in any way, either directly or indirectly (including but not limited to, through a website), another Wellness Advocate or Customer to enrol or participate in another network marketing opportunity. This conduct constitutes recruiting even if the actions of the WA are in response to an inquiry made by another WA or Customer.”

Event hosts may not promote, mention, or discuss other network marketing opportunities.

Violations may result in removal of event listings and reporting to dōTERRA Compliance for further action.

4. Event Content and Conduct

Events must reflect professional, inclusive, and ethical conduct.

Hosts are fully responsible for content shared and interactions during their events.

No misleading, exaggerated, or non-compliant claims about products, income, or wellness outcomes may be made.

Events must follow all relevant legal, local, and venue guidelines.

5. Event Approval and Moderation

All submitted events are subject to review by Calendar administrators.

Events may be edited or rejected if they do not comply with these Terms or dōTERRA's broader guidelines.

Listings that promote divisive, non-compliant, or unauthorized content will not be approved.

6. Cross-Team Collaboration Encouraged

The Calendar exists to foster unity and collaboration across all dōTERRA teams.

Leaders are encouraged to attend, support, and invite broadly without regard to team boundaries.

7. Amendments

These Terms and Conditions may be updated at any time. Continued use of the Calendar after changes are posted constitutes your agreement to the new terms.

8. Disclaimer of Responsibility

This Calendar is a community-driven platform. Events are not organized, operated, or officially endorsed by dōTERRA AUNZ.

dōTERRA does not assume responsibility for the content, quality, legality, or results of any event listed on this Calendar.

Event listings do not constitute sponsorship or approval by dōTERRA, and participation is at your own risk.

It is the sole responsibility of the event host to ensure their content complies with all applicable laws, regulations, and dōTERRA's Policies and Procedures.

By submitting the event form, the host agrees that all information is correct and once the event form is submitted, no further changes are permitted.

The host agrees that the event submission will be sent by the 25th of the month, providing at least 5 days notice.
