Sharer Club 2.0 Period



Sharer Club 2.0 Participants

- Open to **Executive to Platinum Wellness Advocates**
- Qualify as a **Executive** or higher in the qualification month (July)
- Personally enroll **1 New Wellness Advocate** or **Wholesale Customer** (each with a minimum single 100PV enrolment order) during the qualification month (July). Wellness Advocates and Wholesale Customers need to be enrolled in Malaysia. (Wholesale Customer upgrades and reactivations do not count)
- Process a minimum 100PV personal LRP order
- The purpose of the Sharer Club 2.0 program is to help participants to learn key habits that will serve as a strong foundation of their business. Participants should personally involved throughout the Sharer Club 2.0 journey to master new skill and develop necessary skill set to advance in their business



Sharer Club 2.0

Preparation Month (August)

“If you fail to plan, you plan to fail”

In order to have successful events in the Sharer Club 2.0, you will need to be working with your leaders in your home and away area prior to the day of the event. Planning, inviting, and following up are the secrets to getting people to join your events and being able to meet the enrolment requirements.

- Prepare and plan your events month-by-month
(set the dates of your trips and then work with your leaders to fill your schedule on those days)
- Map out your travel plans
- Prepare your teams for scheduled events in their area
- Prepare your household – set up childcare, get your family on-board
- Participate in the Sharer Club 2.0 Kick-Off Meeting
- To submit your following month 4 offline events schedule by 25th

Sharer Club 2.0

Sharer Club 2.0 Period (September - November)

To graduate in this program, you must complete a minimum of 15 Personal Group enrolment with 3 Personal Enrolment by the end of November.

◆ **September : Minimum 3 Personal Group Enrolment**

October : Minimum 3 Personal Group Enrolment

November : Minimum 3 Personal Group Enrolment

▪ **Total at least 3 Personal Enrolment with 15 Personal Group enrolment to graduate in this program.**

◆ Submit your **4 offline meetings** for the following month via the Sharer Club 2.0 portal. All meetings must be submitted before the 25th of each month. Should there be any adjustments to meetings, you may change the details via the Sharer Club 2.0 Portal prior to a particular event

◆ At the end of every meeting, you will have 24 hours to submit your "Event Record", together with event photos via email at mysalesdept@doterra.com. Photos should include the Sharer Club 2.0 participants and attendees.

In order for enrollees from the event to be counted towards your qualified enrolments, names of the enrollees for the event must be submitted through the Sharer Club 2.0 Portal no more than 3 working days after the event.



What is a Mentor?

A mentor is someone who partners with dōTERRA to help participants to achieve success in the Sharer Club 2.0. Mentors play an important role in the leadership duplication cycle. Mentors take responsibility for teaching leadership skills, helping develop action plans, and guiding the participant to be successful. This support could include to schedule accountability calls, support with class preparations, to arrange class follow-up, attending/teaching classes, when possible, help with scheduling and time blocking, and any other necessary support to ensure the participant's success in the program.

There is no financial obligation in being a mentor.

Benefits of Mentoring

Wellness Advocates mentor leaders in Sharer Club 2.0 by partnering with dōTERRA. This partnership helps to develop leaders on the mentor's team and encourages enrolments and rank advancement to organically boost organizational volume and leadership. One of the best investments leaders can make is to invest back into their builders.



Wellness Advocates who are willing to help support and train/mentor participants to be successful in the program and in building their team toward their next rank advancement can apply to become Mentoring Upline Leaders. Qualifications as follows:

- Open to ACTIVE Gold and above
- Have at least 1 downlines to participate in the Sharer Club 2.0



1. For verification purpose, Sharer Club 2.0 participants **must take photos** of the **offline meeting activity**. Participants **must participate / present** in all the event where they have enrolment.
2. Sharer Club 2.0 participants should register attendees' record with their **full name and contact number**. Input this information through the Sharer Club website.
3. Submit event activity record and photos via email to us at mysalesdept@doterra.com **within 24 hours** after conducting the event activity.
4. Complete your **4 offline event meetings** and **3 personal group enrolment for monthly requirement**.
5. Company **reserves the right** to contact new enrollees to verify whether they had participated the offline meeting activity prior to enrolment verification.

New Enrolment Incentive & Promotions

As an added bonus for individuals to enroll as a Wellness Advocate or a Wholesale Customer at a Sharer Club 2.0 event, dōTERRA offers special enrolment promotions during Sharer Club 2.0. Prospective Wellness Advocates and Wholesale Customers must be enrolled by a Sharer Club 2.0 participant in a registered event in order to be eligible for the promotional product.

Promotional product will be announced on a monthly basis via Sharer Club 2.0 WhatsApp group. All new enrolments must have at least a single 100PV enrolling order to qualify for the promotional product.

Only participants personal organization will be eligible the enrolment FREE oils and not eligible for outside team organization

LRP ENHANCEMENT

Sharer Club 2.0 enrollees who set up **a single LRP Malaysia order only** (*combined orders do not count*) during the 2nd month of enrolment, will receive product points on the same month.

A single LRP order of at least 125PV will receive 25 product points

Qualification	Reward
At least 1 Sharer Club 2.0 graduates personally mentored by you (<i>as per registration</i>)	50% entitlement to join the graduation trip.
At least 2 Sharer Club 2.0 graduates personally mentored by you (<i>as per registration</i>)	Eligible to join the graduation trip.

Sharer Club 2.0 FAQ

1. **Is Sharer Club 2.0 open to other dōTERRA markets beside dōTERRA Malaysia?**
- No. Sharer Club 2.0 is only open to **Malaysia Wellness Advocate**.
2. **At what rank can a dōTERRA WA apply to join Sharer Club 2.0?**
- Sharer Club 2.0 is open to all WA starting from the minimum paid rank of **Executive to Platinum**.
3. **I am at Diamond rank, how can i participate in Sharer Club 2.0?**
- For all Diamonds & above, you are not able to participate in Sharer Club 2.0 however **any upline of rank Gold and above can be a Mentor** to the participating Sharer Club 2.0 participant
4. **Can I enroll new members from others dōTERRA market besides Malaysia?**
- New enrolment must be from **Malaysia WA/WC** with **minimum 100PV single order** (*combined order do not count*).
5. **How do enrollee earn 25 points new enrollee promotion?**
- New enrollee will earn 25 product points on their 2nd month of enrolment provided they have **Malaysia 125PV LRP order in a single order**.
6. **How do I submit my event record?**
- Email to mysalesdept@doterra.com your event photo submission with *participant name, ID number, date & time of the event*. Submit your event **within 24 hours after conducting the event**.
7. **Can online event be counted in my event record?**
- Only **offline meetings** are applicable & counted in Sharer Club 2.0.
8. **Does a Sharer Club 2.0 participant need to be present when conducting event?**
- Sharer Club 2.0 participant must **participate or present** in all the event where they have enrolments.
9. **What is the timeline for me to enrol my prospects who joined the event?**
- Enrolment must be submitted **not more than 3 working days** after the event.
10. **Is the Sharer Club 2.0 portal open to others besides the participant?**
- No. **Only Sharer Club 2.0 participant** will be allowed to use the portal for enrolment of this program.
11. **Is the free oil open to all enrolment in this program?**
- **Only Sharer Club 2.0 participant is eligible to offer free oil to their enrollee**. This also apply to their downline who are under the same personal group organization. Mentor will only be eligible if their new enrollee are placed under the Sharer Club 2.0 personal organization to receive this promotion.
12. **If I did not meet the monthly requirement, can I continue the program in the following month?**
- **The participant will be disqualified from Sharer Club 2.0**. The participant must complete the monthly requirements throughout the program period in order to graduate from Sharer Club 2.0.
13. **Can I use my social media to promote the program of the free oil promotion?**
- Sharer Club 2.0 participant and mentor **are not allowed** to promote the free oil promotion in their social media platform.
14. **Will second applicant eligible for the prize (Graduation Trip) if the participant graduate ?**
- For Sharer Club 2.0, **only main applicant can eligible for the winning prize**, however the co-applicant can pay to join the trip.
15. **The graduation trip is considered as a taxable non-monetary incentive and will be reported in your Form CP58 Year 2024 as required by the Inland Revenue Board (IRB) of Malaysia.**
