Participant Qualifications (January or February)

- Open to **Executive and above rank**
- Qualify as a **Executive** or higher in the qualification month (January or February)
- Personally enroll **1 New Wellness Advocate** or **Wholesale Customer** (each with a minimum single 100PV enrollment order) during the qualification month (January or February). Wellness Advocates and Wholesale Customers need to be enrolled in Malaysia or Singapore. (Wholesale Customer upgrades and reactivations do not count)
- Process a minimum 100PV personal LRP order
- The purpose of the MYSG Sharer Club & Launch Club program is to help participants to learn key habits that will serve as a strong foundation of their business. Participants should personally involved throughout the MYSG SC & LC journey to master new skill and develop necessary skill set to advance in their business

Preparation Month (February)

- Prepare your teams for scheduled events in their area
- Prepare your household – set up childcare, get your family on-board

MYSG Sharer Club & Launch Club Period

Participant Qualifications (March-May)

To continue in Sharer Club/Launch Club each month, participants must meet the following monthly requirements:

◆ **2 enrollment per month** -Includes enrollment from Personal Team and Outside Team

4 meetings per month -Offline meeting only

◆ To graduate in this 3-month program, below are the requirements that needs to be achieved:

Tier 1 -Total 15 enrollments from Personal Team & Outside Team

a) min 6 must be from Personal team

b) min 3 must be Personal Enrollment

Tier 2 -Total 15 enrollments from Personal Team Only (min 3 must be Personal Enrollment)

◆ Submit your **4 offline meetings** for the following month via the Sharer Club/Launch Club portal portal. All meetings must be submitted before the 25th of each month. Should there be any adjustments to meetings, you may change the details via the Sharer Club & Launch Club Portal prior to a particular event

◆ At the end of every meeting, you will have 24 hours to submit your "Event Record", together with event photos via email at mysalesdept@doterra.com, same goes with Launch Club via email to jlin@doterra.com. Photos should include the SC/LC participants and attendees.

In order for enrollees from the event to be counted towards your qualified enrollments, names of the enrollees for the event must be submitted through the SC/LC portal no more than 3 working days after the event.

Offline Meeting Rules

1. For verification purpose, MYSG Sharer Club & Launch Club participants **must take photos** of the **offline meeting activity**. Participants **must participate / present** in all the event where they have enrollment.
2. MYSG Sharer Club & Launch Club participants should register attendees' record with their **full name and contact number**. Input this information through the Sharer Club/Launch Club portal.
3. Submit event activity record and photos via email to us at mysalesdept@doterra.com **within 24 hours** after conducting the event activity. For Launch Club email at jlin@doterra.com.
4. Complete your **4 offline event meetings** and **2 enrollment for monthly requirement**.
5. Company **reserves the right** to contact new enrollees to verify whether they had participated the offline meeting activity prior to enrollment verification.

New Enrollment Incentive & Promotions

MYSG Sharer Club & Launch Club FAQ

1. **Is MYSG Sharer Club & Launch Club open to other doterra markets beside doTERRA Malaysia?**
- MYSG Sharer Club & Launch Club is only open to **Malaysia and Singapore Wellness Advocate**.
2. **At what rank can a doTERRA WA apply to join MYSG Sharer Club & Launch Club?**
- MYSG Sharer Club & Launch Club is open to all WA starting from **minimum paid rank of Executive and above in January-February**.
3. **Can I enroll new members from others doterra market besides Malaysia for Sharer Club and Singapore for Launch Club?**
- New enrollment must be from **Malaysia WA/WC for Sharer Club and Singapore WA/WC for Launch Club with minimum 100PV single order** (combined order do not be count).
4. **How do I submit my event record?**
- Email to **mysalesdept@doterra.com** for Sharer Club and send to **jlin@doterra.com** for Launch Club with participant name, ID number, date & time of the event. Submit your event within 24 hours after conducting the event.
5. **Can online event be counted in my event record?**
- Only **offline meetings** are counted in Sharer Club and Launch Club. However, participants is allowed to do online meetings.
6. **Does a Sharer Club & Launch Club participant need to be present when conducting event?**
- Sharer Club & Launch Club participant must **participate or present** in all the event where they have enrollments.
7. **What is the timeline for me to enroll my prospects who joined the event?**
- Enrollment must be submitted **not more than 3 working days** after the event.
8. **Is the Sharer Club & Launch Club portal open to others besides the participant?**
- No. **Only Sharer Club & Launch Club participant** will be allowed to use the portal for enrollment of this program.
9. **Is the free oil open to all enrollment in this program?**
- **Only Sharer Club & Launch Club participant is eligible to offer free oil to their enrollee**. This also apply to their downline who are under the same personal group organization.
10. **If I did not meet the monthly requirement, can I continue the program in the following month?**
- **The participant will be disqualified from Sharer Club & Launch Club**. The participant must complete the monthly requirements throughout the program period in order to graduate from Sharer Club & Launch Club.
11. **Can I use my social media to promote the program of the free oil promotion?**
