How to qualify:

NEW Silver+ Rank (May - October 2026)

- 1) Achieve a minimum rank of Silver
- 2) Requalify your new rank at least once
- 3) Achieve the required number of personal enrollments
- 4) Personally enroll a new Elite+

EXISTING Silver+ Rank (Before May 2026)

- 1) Requalify your current rank in accordance with the stated requirements
- 2) Achieve the required number of personal enrollments
- 3) Personally enroll a new Elite+

Qualification Period - May - October 2026 (6 months)

Travel period: January 2027

Full Qualification Criteria

- Qualification Period:** May to October 2026 (6 months)
- Eligibility:** Open to new Silver and existing Silver-and-above Wellness Advocates from Malaysia, Singapore, Thailand, and the Philippines.
- Rank Requirement:** Participants must advance by at least one rank (*minimum Silver*) and/or maintain the new rank for the required number of months.
- Enrollment Requirement:** New enrollments may be either Wellness Advocates (WA) from Thailand, Malaysia, Singapore, or the Philippines, each with a minimum single enrollment order of 100 PV.
- Development Requirement:** Personally enroll at least one new Elite (*or higher*) rank.
- Rank-Specific Rules:** Please refer to the table below for detailed requirements for each rank.

Terms & Conditions

1. This contest is open to new and existing Silver and above Wellness Advocates (WA) from Thailand, Malaysia, Singapore, or the Philippines.
2. Participants must be at least 18 years of age.
3. Qualifiers must maintain a minimum monthly 100 PV LRP order from May to October 2026. Failure to meet this requirement will result in disqualification.
4. New enrollments may be either Wellness Advocates (WA), each with a minimum single enrollment order of 100 PV.
5. New enrollments must be from Thailand, Malaysia, Singapore, or the Philippines.
6. Transferring an enrollment to another member during the qualification period will result in the loss of eligibility for that enrollment.
7. If a new enrollee returns products or terminates their account before the end of the promotion period, the enrollment will be disqualified.
8. Reactivations and account transfers will NOT be counted as new enrollments.
9. Each winner is entitled to either one or two spots. This contest is limited to one winner per account. Additional people need to be from co-applicant or family members, not their downlines.
10. If a qualifier is unable to attend the trip, the prize will be forfeited. Prizes are non-refundable, non-exchangeable for cash, and non-transferable.
11. Participants are responsible for any additional costs, including visa application fees (if applicable) for the Hokkaido trip.
12. Accommodation will be arranged on a twin-sharing basis with other winners.
13. Travel will be arranged via budget airlines.
14. Participants are responsible for any additional personal expenses, including outstation travel, extra accommodation, and related costs. Participants from other countries should refer to their respective local arrangements.
15. Participants requiring special assistance are advised to travel with a companion at their own expense.
16. The Company reserves the right to modify or cancel the trip due to force majeure events, including but not limited to natural disasters, fires, infectious disease outbreaks, war, government orders (*including travel restrictions*), strikes, or temporary closure of transport or accommodation providers.
17. This incentive trip is considered as a taxable non-monetary incentive and will be reported in your personal revenue and subject to pay reward & prize tax for 5%
18. Participants are responsible for ensuring they are fit to travel. It is recommended to consult a doctor at least six weeks prior to departure.
19. Participants must remain in good standing and comply fully with company policies throughout the qualification period and prior to travel.
