Keep Gardening

"Building a business isn't for the faint of heart. It's not a get-rich-quick endeavor either. It takes time, patience, consistency, and grit. Motivation is fleeting—it takes discipline. You have to adapt, while also still serving your customers from a place of love. There'll always be hard days, but it's how you choose to respond to circumstances that matters."—Sara Worth

Like many people, Sara was initially uninterested in building a doTERRA® business. But after enough time, multiple invitations from her upline, and too many incredible experiences with the products to ignore, Sara jumped in with both feet. She says, "I couldn't keep my mouth shut. I remember thinking, Everyone needs to know about these gifts of the earth!"

No one's path to Diamond rank is smooth; for Sara, it took nine years of dedication. She often reflects on how long it took and the tenacity it required to keep going when others may have given up. She says, "I'm not going to lie, some days were hard because comparison crept in. I saw others growing faster than me, and I sometimes thought I was failing because I was taking longer. I've always tried to remind myself to stay in my own lane, be consistent, and show up."

After building for five years, Sara and her husband moved to a new state where they didn't know a soul. Building suddenly became a lot more difficult. Sara was used to teaching classes and hosting events with a thriving, local network that just kept growing, but now she knew no one. She realized she needed to adapt and expand her strategy. "I decided to try a social media page. It took me a full year of daily posts before I got my first online enrollment, but it was so worth it. I love sharing online, and it's changed my life and business for the better. I've connected and built relationships with the most amazing people I never would've known if it weren't for social media. It's been so fun to create a loving essential oil community online."

Sara has experienced the importance of consistency. She says, "Lead by example, continually doing the daily things that build your business and nourish your network. I love thinking of this business as a garden. You're the gardener. You plant seeds with new people by sharing these products. You water and nourish your garden network by following up and serving your customers. Sometimes you're called to prune your tree and remove the dead branches or leaves—the people who are no longer ordering or engaged. Sometimes you have to pluck out the weeds of your own self-limiting beliefs."

She continues, "It's a helpful analogy for how you approach your business. When you first plant seeds, you don't know which ones will shoot up, which will wither, and which will slowly take root. You nourish them all with love and compassion and create an environment where your people can blossom and start planting their own gardens. It can take a while to see the sprouts and growth from the seeds you planted, so don't give up. Keep gardening."

Grow with Your Team

"If there's anything I've learned, it's that you can't succeed in this business by yourself. You need other people to link arms with—who have their own goals and visions and believe they're achievable. Trust that there are people out there who'll catch the vision and be drawn to it. Those are your people!"

Ory and Obando Gonzalez have learned sometimes you have to hold tight onto the things that matter most, and other times you just have to let go.

When reflecting on her doTERRA® journey, Ory remembers one of the hardest challenges of building her business: losing several leaders and two legs in the same month. This loss was a huge blow to Ory's business and family. Not only did Ory and Obando worry about how they'd rebuild the team, but they also contemplated what this would do to their finances. It cut their next month's income in half.

Though she was deflated, Ory wouldn't be discouraged. She says, "I relied on my strengths and dedicated my time to leaders I knew wanted to run this race with me. This choice allowed me to rebuild and solidify my rank three months later." By clinging to her business when her remaining leaders needed her the most, Ory rebuilt to her former success—and beyond.

Later, Ory learned it's sometimes better to let go. When asked what advice she'd give others who are building a dōTERRA® business, she says, "If I could turn back time, I'd recommend making peace by letting go. Sometimes, we cling to leaders or aspects of the organization we think are ready to grow but aren't. Unfortunately, holding onto something that isn't working is like trying to run with a suitcase full of stones. It weighs us down and prevents us from moving forward."

Ory always prioritizes her commitment to her leaders. Her leaders know they can always count on her. She's always available to help. She loves helping her leaders plan their goals, deciding together how to best achieve them.

According to Ory, when she focuses on committing to her leaders—to those who truly want to build and grow with her—it becomes easier to let the smaller details go. She says, "Letting go is one of the biggest things I've learned by building my business." Now as a Diamond, she knows some aspects are worth holding onto, but sometimes you'll make it further if you simply let go.

Managing Your Business While Managing a Family

Ory and Obando know how difficult it is to blend business with family life. Here's some advice they have about trying to navigate parenthood and family life while building a successful business:

- Focus on your Why every single day.
- Remember, these sacrifices are temporary, but their fruits will stretch far into the future.
- Be intentional about how you spend your time, as good time management is essential.
- Keep in mind you're a team. Share responsibilities in both your family and business.
- Schedule fun time—if you don't prioritize family and fun, it won't happen. Add family time to your calendar and intentionally plan business activities with the remaining time.

Tell us about your journey to Presidential Diamond.

In 2018, I was a photographer in Miami, where I emigrated four years before. I began using the products but had no interest in doing the business. After having great experiences with the product, I became the most loyal customer: buying all kinds of products every month. I began unconsciously sharing the benefits with my community on Instagram. Six months later, a good friend of mine asked me to get her a kit for her daughter. At that point, I realized I could make some extra income beyond my photography business.

In January 2019, I officially upgraded to Wellness Advocate. I saw doTERRA as an opportunity to transition into a new entrepreneurial experience—working from home with a small investment. I was ready for change!

From that moment, doTERRA has been an incredible experience. We hit Presidential Diamond in 18 months and achieved several Founder's Club positions, leading a fantastic team of Spanish-speaking entrepreneurs worldwide through social media.*

What's the biggest lesson you've learned? What have been the biggest hurdles you've had to overcome?

The biggest lesson I've learned is that anything you dream of is possible, not ot only if you believe you can, but if you set goals and show up with commitment. Consistency is vital. If you persist, you'll make it. It's definitely not about if you can or can't but if you will or won't. Taking action and putting your ideas in motion is key.

On the other hand, the biggest hurdle has been helping the women in my organization believe in themselves and defeat their limiting beliefs. I tell my teammates it's ok to feel fear, but they need to find space for courage. Another challenge is teaching them this business is a marathon, not a sprint race, so I help them to cultivate a long-term vision.

What advice would you give to someone trying to reach Presidential Diamond?

Build a solid organic foundation. If you want time-freedom, your leaders need to learn how to take care of their organizations. Make sure they're empowered, independent, and self-motivated. They should have a strong vision, like yours. I would also recommend you help your team build a solid Diamond leaders, because they'll be more committed and you'll become more stable. Don't rush: a rank doesn't mean anything if you can't maintain it.

How do you and your spouse work together in the business? What advice do you have for couples working together?

Victor has been my biggest support from day one. In the early stages of my business, he helped me with our baby and household errands, so I could teach classes and support my customers.

Nowadays he's become my partner, very involved with all the administrative and financial matters. He arranges all the travel logistics and organizes events. Victor also helps with skeptical husbands. He shares the masculine vision of the products and the business. Since I'm focusing more on education for my team, he's been enrolling more than me!

How have you learned to balance running your business and taking care of your family?

It's been very challenging. I'm an overachiever and always feel there's not enough time to get things done. Being productive makes me feel amazing. It's adrenaline. I've learned to set alarms to stop working, because I have a lot of fun creating new things for my team. Thank God my family has been very supportive, and they understand all this time invested in dōTERRA is for them and for our future.

I recently began taking the quality time I spend with my family very seriously. I no longer work on weekends, and we have a yearly calendar full of family trips and activities. I finally feel my organization has reached a position where I can relax a little more without losing focus on my team's growth.

At this stage, what motivates you to continue building your business?

As a Venezuelan immigrant, it inspires me to see how other immigrant women can achieve their financial goals by partnering with such a fantastic company. Most of us leave our countries with a suitcase full of dreams. It's challenging starting from zero in a new country—especially with a different language. But doTERRA allows us to build an international business, no matter our professional experience, background, or location. I want to tell the world this is the best business model for entrepreneurs to meet their financial goals and become the best person they can be. And all while helping others. It's a no-brainer: everybody needs to know about this opportunity. That's what motivates me.

In what ways has your doTERRA business changed your life?

It's helped me grow a healthy mindset—changing my perspective on how I manage different situations. Professionally speaking, it's expanded my toolset and skillset. I can keep growing my business and help others to do the same.

Family-wise, this business has allowed us to dream about things that weren't possible before. It's already ensured proper education for our children. Plus, with all the blessings we've received, we can give back to our country—Venezuela—through our Social Project, danDÕ & donanDÕ. We take food and basic living supplies to support hospitals around the country.

dōTERRA is a personal development business wrapped in essential oils. It's a blessing to be part of this family. My Why is showing more Latin women this opportunity could change their lives for good. Thank you, dōTERRA.

Cuéntanos sobre tu viaje a Diamante Presidencial.

En el 2018 trabajaba como fotógrafa de bebés y niños en Miami, donde había emigrado cuatro años antes. Empecé a usar los productos y como tenía tan buenas experiencias, me convertí en la clienta más fiel: compraba muchos productos todos los meses. Honestamente en un principio no tenía interés en hacer el negocio, pero comencé inconscientemente a compartir los beneficios con mi comunidad en Instagram. Seis meses después, una buena amiga me preguntó si podía comprarme un kit para su hija y en ese momento me di cuenta de que podía generar ingresos adicionales más allá de mi negocio de fotografía.

En enero de 2019, cambié oficialmente mi cuenta a Distribuidor Independiente porque vi do TERRA como una oportunidad para hacer la transición a un nuevo emprendimiento, pero esta vez trabajando desde casa y con una inversión mínima. ¡Estaba lista para el cambio!

Desde ese momento, dōTERRA ha sido una experiencia de crecimiento increíble. Llegamos a Diamante Presidencial en tan solo 18 meses y logramos varias posiciones en diferentes Club de Fundadores, liderando un fantástico equipo de emprendedores de habla hispana a nivel mundial, usando redes sociales.*

¿Cuál es la mayor lección que has aprendido? ¿Cuáles han sido los mayores obstáculos que has tenido que superar?

La mayor lección es haber comprobado que definitivamente todo lo que sueñas es posible. Pero no sólo hace falta creer, hay que fijarse metas y presentarse con compromiso. La consistencia es vital. El que sigue, lo consigue. Definitivamente no se trata de si puedes o no puedes, sino de si lo harás o no lo harás. Pasar a la acción y poner tus ideas en marcha, es clave.

Por otro lado, el mayor reto ha sido ayudar a las mujeres de mi organización a creer en sí mismas, ayudarlas a derrumbar sus creencias limitantes. Les digo a mis chicas que está bien sentir miedo, pero necesitan encontrar espacio para la valentía. Otro desafío es enseñarles que este negocio es un maratón, no una carrera de velocidad, por eso también las ayudo a cultivar una visión a largo plazo.

¿Qué consejo le darías a alguien que intenta llegar a Diamante Presidencial?

Construye una organización con bases orgánicamente sólidas. Si tu deseo es tener tiempo libre, tus líderes deben aprender a hacerse cargo de sus organizaciones. Asegúrate de que estén empoderados, que sean independientes y que estén automotivados. Deben tener una visión fuerte, como la tuya. También te recomiendo que ayudes a tus líderes frontales a construir un Diamante sólido, porque estarán más comprometidos y tú también estarás más estable. Y por último, no te apresures en construirlo rápido: un rango no significa nada si no puedes mantenerlo.

¿Cómo trabajas junto a tu esposo en el negocio? ¿Qué consejo tienes para las parejas que trabajan juntas?

Victor ha sido mi mayor apoyo desde el primer día. En las primeras etapas de mi negocio, me ayudaba con las labores del hogar y con nuestro bebé, para que yo pudiera dar clases y apoyar a mis clientes.

Hoy en día se ha convertido en mi socio, muy involucrado con todos los asuntos administrativos y financieros. Se encarga de toda la logística de viajes y hasta organiza eventos. Víctor también ayuda con los maridos escépticos, compartiéndoles la visión masculina de los productos y del negocio. Como actualmente yo me estoy enfocando más en la educación de mi equipo, ¡él ha estado inscribiendo, incluso más que yo!

¿Cómo has aprendido a balancear tu negocio y el cuidado de tu familia?

Honestamente ha sido muy retador. Me pongo objetivos grandes y siempre siento que no hay suficiente tiempo para hacer las cosas. Ser productiva me hace sentir increíble, es como adrenalina. Entonces he tenido que aprender a programar alarmas para dejar de trabajar, porque me divierto mucho creando cosas nuevas para mi equipo. Gracias a Dios, mi familia me ha apoyado mucho y entienden que todo este tiempo invertido en doTERRA es para ellos y para nuestro futuro.

Recientemente comencé a tomar muy en serio el tiempo de calidad que paso con ellos y ya no trabajo los fines de semana. También tenemos un calendario anual lleno de viajes y actividades familiares. - Work alongside people and lead by example.




After eight years of hard work and progress with a different direct sales company, Amy realized she needed a change. She was a top earner and had achieved the top rank, yet something was missing. Amy says, "Even though I experienced a lot of success, I realized I'd never have the time freedom or make the impact I wanted."

heavy lifting. I was confident doing my best would be enough." She and her team focused on implementing the basics of PIPES, having a clear system for launching new builders, and training other team members to duplicate and scale. Building with this strong foundation has paid off immensely.






